



# CAMPAIGN TO **STOP** KILLER ROBOTS

## Membership Agreement

The following Membership Agreement describes the responsibilities that members, staff, and the Steering Committee agree to by joining and participating in the Campaign to Stop Killer Robots:

### **All Members**

All members of the Campaign to Stop Killer Robots agree to:

- Endorse and actively work to support the Campaign's goal of a ban on fully autonomous weapons in order to retain meaningful human control over the use of force;
- Share information on plans, activities, major developments, and issues relating to the Campaign's goal with staff and other coalition members;
- Positively and constructively engage with other members, staff, governments and other relevant actors at a local, national, and/or international level;
- Participate in joint global campaign actions and contribute to consultations whenever feasible;
- Commit to transparency, accountability, and good governance in our work to ban killer robots;
- Commit to follow the Code of Conduct of the Campaign to Stop Killer Robots during meetings and events.

All members are entitled and encouraged to:

- Subscribe to the coalition's mailing list of member organisations to receive campaign updates from members, staff, and the Steering Committee;
- Request, use, and publicize Campaign to Stop Killer Robots materials in accordance with the Campaign's communications policies;
- Add the Campaign to Stop Killer Robots logo to their website or materials, noting that they are a member of the Campaign. We kindly request that members do not use the logo in any way materially inconsistent with the Branding Guidelines;
- Seek technical and strategic support from the Campaign to Stop Killer Robots Steering Committee and staff.

**Campaign to Stop Killer Robots staff** - who provide administrative, advocacy, financial, logistical, media, and policy support to Campaign to Stop Killer Robots members - agree to:

- Provide advice, encouragement, and support to all campaign members;
- Share regular information on campaign activities, actions, and available resources;
- Facilitate and coordinate the coalition, including dispute resolution;

- Support campaign engagement internationally, including management of participation in meetings;
- Consult with members including on issues and opportunities, policy development, campaign structure and practices;
- Hold personal data about Campaign to Stop Killer Robots members only for the purposes outlined in this membership agreement and not to sell or otherwise transmit data to non-members without explicit consent, and adhere to the Campaign to Stop Killer Robots [Privacy Policy](#).

The **Steering Committee**, which oversees the work of the Campaign to Stop Killer Robots, agrees to:

- Appoint Steering Committee members and other campaign bodies and positions;
- Ensure strategic planning and policy development to achieve the campaign's goal;
- Approve the Campaign's budget, fundraising proposals, and financial reports;
- Ensure the Campaign complies with its legal and financial obligations;
- Approve documents and other materials issued in the name of the Campaign;
- Approve applications of membership from NGOs to join the Campaign;
- Ensure quality assurance including monitoring and regular evaluation;
- Conduct regular consultation and engagement with the membership;
- Oversee the work of dedicated staff and ensure good employment practices.

Note that the Campaign to Stop Killer Robots reserves the right to revoke membership for any deemed violation of the Campaign's values, principles, and Code of Conduct, or if the member ceases or fundamentally changes the nature of its operations entirely or with respect to its position on fully autonomous weapons, to be determined at the discretion of the Campaign to Stop Killer Robots Steering Committee.
