Biographies of Speakers

Bonnie Docherty, Human Rights Watch

Ms. Docherty is a lecturer on law and senior clinical instructor at Harvard Law School's International Human Rights Clinic and senior researcher in the Arms Division at Human Rights Watch. Docherty's 2012 "Losing Humanity" report has been credited with sparking the international debate on fully autonomous weapons. She is the author of a 2015 report on accountability concerns as well as a 2014 report on the human rights law implications of weapons that would select and attack targets without meaningful human control. @hrw @HmnRightsProgram

Peter Herby, Norwegian Red Cross

Mr. Herby has supported work on arms issues for the Red Cross/Crescent Movement as arms adviser for the Norwegian Red Cross (Norges Røde Kors) since 2012. Before that, he was the head of the arms unit in the legal division of the International Committee of the Red Cross (ICRC). Between 1994 and 2012, Herby represented the ICRC at arms negotiations that resulted in the adoption three protocols to the Convention on Conventional Weapons as well as the Mine Ban Treaty, Convention on Cluster Munitions, and Arms Trade Treaty. He directed the disarmament program of the Quaker United Nations Office in Geneva from 1983 to 1993.

Maya Brehm, Geneva Academy of International Humanitarian Law and Human Rights

Ms. Brehm is a researcher in weapons law at the Geneva Academy of International Humanitarian Law and Human Rights. Previously, Ms. Brehm led a research project at the UN Institute for Disarmament Research, worked as a protection delegate for the International Committee of the Red Cross, and consulted for the NGO Article 36. Ms. Brehm holds an MA in international relations and an LL.M in international humanitarian law. @schoggitaler @geneva_academy

Thompson Chengeta, International Committee for Robot Arms Control

Dr. Chengeta is currently serving as a post-doctoral fellow at the South African National Chair for International Law. He is also a non-resident fellow at the University of Pretoria's Institute for International and Comparative Law in Africa and an extraordinary professor at its Centre for Human Rights. Chengeta is a member of the International Committee for Robots Arms Control (ICRAC), a campaign co-founder. From 2012 to 2015, he worked as lead researcher for the UN Special Rapporteur on extra-judicial killings, summary or arbitrary executions, Professor Christof Heyns. In 2015, Dr. Chengeta completed his Ph.D at the University of Pretoria on the subject of legal solutions to concerns over autonomous weapon systems. He has a LLM from Harvard Law School. @DrThompsonLaw
